## AFFIDAVIT FOR SEARCH WARRANT

Deputy Marshal Levi P. App, Cloverdale Police Department, being first duly sworn upon his oath deposes and says that he has good cause to believe narcotics and narcotic paraphernalia, monies related to the distribution and sales of narcotics are within the residence and all out buildings, and vehicles linking to and attached to the property of Ms. Donna Dibiase, located at 316 Lazy River Road, Cloverdale, Indiana 46120.

I seek to seize the following items:

- 1. Narcotics
- 2. Narcotic Paraphernalia
- 3. Articles related to the distribution, manufacture and sales of narcotics.

In support of the assertion of this affiant as to the existence of probable cause for the search, I offer the following facts and circumstances:

- 1. On September 29, 2020 at approximately 7:33 PM I responded to a call at the Marathon Gas Station at the intersection of Main and Market Street in Cloverdale. Upon My arrival I found Jesse Monnett inside of his vehicle at the gas pumps. I observed Mr. Monnett to be in a state of paranoia and extremely fidgety. I believed him to be under the influence of narcotics. As my investigation continued I developed probable cause to believe he had Operated the Vehicle Under the influence. He was then transported to the Putnam County Hospital where he submitted to chemical test. His test results showed a positive result for Methamphetamines. Mr. Monnett was then placed under arrest for operating under the influence of a controlled substance.
- 2. As I was booking Mr. Monnett into the Putnam County Jail he was found to be in possession of two individual baggies of a white crystalline material which later field tested positive for methamphetamine. He was also in possession of a baggie containing a plant like material. I then Mirandized him where he asked if he could speak with me.
- 3. After ensuring he understood his rights I then asked him what he would like to speak about. He stated that he needed help and that he was attempting to make money. He stated that he had recently been given an Ounce of methamphetamine and asked to distribute it. Stating that he was "quoted at \$450.00 to \$600.00" for selling the methamphetamine. I then asked where he was receiving the Methamphetamine. He then asked me if I remembered the lady that showed up at the gas station while he was there with me and was giving him a hug saying it was all going to be ok. He then stated that her name was Donna Dibiase, who I was in fact familiar with. He stated that she was offering to help him make money if he would help her sale narcotics.

- 4. He then said that he was just at Ms. Dibiase's trailer 316 Lazy River Road where he received the bags that I located on him, he was instructed to go to "a ladies house around the corner" that was asking to buy the drugs. He said while he was inside of Dibiase's house he observed there to be "alot of cash and drugs hidden inside of a false wall in "the bedroom". He also stated that he had observed on multiple other occasions there be drug activity and ounces of methamphetamine inside the residence. Furthermore he stated that he observed Ms. Dibase and her friends placing methamphetamine inside of an unknown males motorcycle. He stated that the handle bars were hollowed out so they could put drugs inside of it. He stated that he knew one of the guys was a member of the Sons of Silence, and that he knew him by the name of "Hill Billy."
- 5. Furthermore on May 30, 2020 I arrested an individual by the name of Chad Wilson, for possession of methamphetamine. Who was last seen at the aforementioned residence prior to the traffic stop leading to his arrest. Mr. Wilson was interviewed the next day where he stated that he in fact has purchased methamphetamine from Donna Dibiase.
- 6. All information was given within a short period of time resulting in my belief that the narcotics and aforementioned illicit materials are still located at 316 Lazy River Road Cloverdale Indiana.

The Foregoing represents the grounds for the belief by this affiant. Therefore, this affiant respectfully requests the court to issue a search warrant, directing a search for and a seizure of the property described above.
