After going through my email records I noticed that you submitted a complaint about user generated content (UGC) on CyberbullyingReport.com created by a user or multiple users in good standing. Although it is not possible to have UGC administratively removed from CyberbullyingReport.com without proving that the author has violated the TOU there is a new way to remove CyberbullyingReport.com content from search engines.

CyberbullyingReport.com is part of the No Limit List Corporate Advocacy Program which lets paying customers improve their search results with tag optimization that turns negatives into positives or removes pages from search engines entirely depending on the package. You can confirm

CyberbullyingReport.com's membership in the program by visiting NLLCAP for CyberbullyingReport.com. Join NLLCAP before the end of the week to take advantage of the 50% Off After New Years Sale.

Thank you for using Cyberbullying Report.

Please do not threaten me. You don't know me, but if you did you would know that threats are no more effective on me than courts. If I intended to grant courts policy exemptions or other special privileges I would not use offshore registration and hosting solutions. Like it or not I am the only American with any regulatory authority here. That being said do you want to take advantage of the 50% off sale or do you want to pay full price next week?

I don't mean to sound rude, but you have to understand that I am busy and I don't have time to babysit grown adults. If you can't work things out on your own with the author I'm willing to help you, but just so you know opportunity costs prevent me from helping people in "he said she said" scenarios unless they make it economically viable to do so. Are you economically viable?

No offense, but after glancing at your blog it wouldn't surprise me if you're a possible medium risk client. Your site looks like the typical local political rant blog in that it looks to be full of one sided arguments in which you appear to attack your opponents. I don't know anything about you or politics in Sierra Madre beyond Googling you just now, but you look like the kind of guy who puts himself out there by being publicly vocal with your opinions in ways that many people probably take issue with. Personally I don't have a problem with that because I've angered many with my own views, but I don't think I need to tell you that people in our position should expect to have to take it like we give it.

If you don't want sign up for NLLCAP I understand because I've had to deal with incidents myself like when a disgruntled former user started stalking me before posting false information on sites with reputation management services nearly identical to mine. I never purchased those services because they are more expensive than mine (ex: \$7,500 flat fee for Ripoff Report) and they don't do as much.

Unlike them I offer to completely block pages from search engines and provide professional SEO advice for people like you whose top results lack assets under their control.

I believe that no matter what the author chooses to do with their work that you would get your money's worth, especially during the 50% off sale. Given your notoriety and the high ranking of the article I recommend purchasing a Gold Package and opting out of author mediation so that the page can just fall out of the results without the risk of angering the author into possibly posting the same thing elsewhere.
